# REGULAR COUNCIL MEETING MINUTES April 18<sup>th</sup>, 2017 7:00 p.m.

Mayor Clark called the meeting to order at 7:00pm and led the Pledge of Allegiance.

### **Approval of Minutes:**

There were a few amendments to the regular March 21<sup>st</sup> Council meeting minutes. On page 4, Ord. 2017-04, to make clear that Paula and Giles voted yes, to set the Village Administers high cap at \$27.

On page 4, in the paragraph regarding Jessica Hopkins, it should say "enforcing", not "enacting". On Res. 2017-10, the amount in the resolution paragraph should be \$371,810.39.

#### Citizens:

Mrs. Yarolin, of Pioneer Trail, inquired as to why she and Mrs. Ramsay have to pay \$250 each for a site plan review for their tie in. She was very frustrated by the whole circumstance of the tie in and was requesting answers. Rich explained that it is the County that is enforcing the tie in and that the Village is only trying to help provide assistance with a professional engineer to give guidance with plan reviews.

Jeff Benner told Council that they are agreeing to the bike-n-hike easement for Mill St. He then explained that his partner Eric, was found in violation of an ordinance and wanted to make things right. The Army Corp of Engineers have been working with Eric and Jeff to get into compliance. Jeff stated that he had a signed copy from Rich from the 1990's saying that they were in a flood zone, but not a flood way, and that they did not know that they needed a new permit since he already had a signed paper. They were unaware that they could not fill, and the fill has since been removed. Jeff will be working on correcting their violation.

Brian Perkins, chairman for the Potato Fest, spoke to Council about all the different facets of the festival that he would like to change and incorporate. He would like to add new electrical outlet poles, which he stated that electricians have been kind enough to donate their time and materials to the cause. He would like to incorporate a K-9 dog dash which would require a 27,000 gallon pool, set up the tent for the World's Largest Pierogi Contest on the basketball court, set up vendors along the road on E. High St. and to hang a banner across Rt. 44. He has been in contact with OUPS, and discussed various scenarios with the Chief and Council to make sure everyone is on the same page and everything is safe.

Council also requested additional fencing around the dog pool, which would keep the dogs in, and keep people out.

The Mayor and John attended a meeting in Mentor regarding a Senate bill and regulations to be passed concerning water and waste water. The Mayor will be giving Bruce a copy so that he is informed.

The Village has received \$250 from Mrs. Yarolin and Mrs. Ramsay each, for a site plan review from CT consultants for their sewer tie in.

Jenny is real busy right now with taxes, and noticed some of the new HB 5 rules coming into play, such as if a resident owes less than \$10 they don't have to pay anything. She has seen it a few times with businesses, but only one resident.

## **Department Heads and Village Engineer**

#### **Police Chief Buchert:**

The Police Dept. received more donations for the K-9 Program in the amount of close to \$2,600.

The 911 system for the county is moving forward. The initial start date of May 8<sup>th</sup> has been pushed back, to as early as June or as late as September. The Village was left out, and so the Police Dept. has been working with AT&T and the 911 coordinator from Portage County. The estimate is \$19,500 a year. The Chief asked for a motion from Council to approve the expenditures as they come in since it is over \$3,000.

### Village Administrator:

Service crew has been getting everything ready for paving this summer with Todd Lamb. They are looking at doing a base on Grand Elm St., paving the east side of Mill St., spots on Woodford St. and finishing Oak St. Bruce will have more together for the next Service meeting.

The Bobcat mini is scheduled to be sent on April 24<sup>th</sup>.

They are disassembling the plows and are getting ready for mowing.

Bruce asked Council to make a motion to accept donations from Chelsea for the little library and a 60 cup coffee maker for the park lodge estimated at \$95.

## **Village Engineer from C.T. Consultants:**

Rich mentioned that Jeff had given the okay earlier in the meeting for the easement, and so the following day there will be an appraiser sent out. Eric and Jeff had donated a portion of land for an easement of a value of approximately \$25,000. Rich will get the easement document written up. The Mayor asked what the status was for the paving and storm sewers for W. Prospect St.

Rich said that he spoke to Brian and they should know something by Friday.

The Mayor said that no matter what, something needs to be done on W. Prospect.

She also said that Council might want to consider OPWC for valve replacements.

#### **Committees**

#### John Clark for Service and Fire Board:

Service has been covered. The Fire Board is soliciting quotes to replace the roof, and so far they have only received 1 quote. It's a metal roof estimated at around \$175,000.

They have also received 7 quotes for a new squad purchase, they are being very competitive.

### Marty Hura for Parks and Shade Tree:

Marty mentioned that Chelsea had designed a Buchert Park pamphlet with information and prices regarding park rentals and park information to help advertise.

Arbor Day is that weekend, and is asking Council for a motion to accept a donation.

## Mayor Clark for Planning, Cemetery, and Board of Zoning Appeals:

Planning is working on subdivision regulations and will be doing some tweaking on signs. The Cemetery Board had a meeting, they want to leave the urns at the mausoleum and make them a permanent fixture. They were ok with the flowers that were ordered, and Patty will be spray painting the urns. The Trustees are requesting help with weeding the flower beds and rototilling, for when they start planting the weekend of May 20<sup>th</sup>. They are asking if the Village can water the hanging baskets in the 2 gardens by the mausoleum and memorial gardens. The Board also discussed possible legislation to make changes regarding the cemetery, but no one felt there needed to be any changes.

#### Paula Tubalkain for Finance:

Paula said that they discussed the grant a lot at the meeting the night before. She also recommended more of Council to attend the conference that she had just attended with Jenny. She found it very informative and there was even a round table discussion for Villages. Paula was impressed with 5 year plans that she had heard about, and thought that it would be beneficial for the Village to put together the same to log when things have happened and when things may need replacing, for example. She felt this would also be helpful for any new hires.
