ORDINANCE 2011-71

AN ORDINANCE ESTABLISHING THE PAY SCALES AND POSITIONS OF NEWLY-HIRED FULL TIME AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA, REPEALING ALL PRIOR INCONSISTENT ORDINANCES, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

SECTION 1: Effective September 20th, 2011, the compensation rates of newly-hired Village employees be and are hereby established.
