**RESOLUTION 2011-85**

**A RESOLUTION AUTHORIZING CERTAIN FUND TRANSFERS BY THE CLERK-TREASURER BETWEEN THE WATER AND SEWER OPERATING FUNDS, RESPECTIVELY, AND THEIR RESPECTIVE DEBT SERVICE RESERVE FUNDS, ALL NECESSARY TO MEET CALENDAR 2012 DEBT SERVICE REQUIREMENTS, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village is obligated to make the semi annual debt service payments to the Ohio Water Development Authority (OWDA) in June 2012 and December 2012, and semi annual debt service payments the Ohio Public Works Commission (OPWC) in June 2012 and December 2012; and

**WHEREAS**, it is necessary for the Village Council to authorize monthly transfers to accumulate the funds needed to make these debt service payments; and

**WHEREAS**, the Village Council wishes to authorize the necessary transfers for the whole of fiscal year 2012 without taking separate action each month.

**NOW THEREFORE, BE IT RESOLVED**, by the Village of Mantua, Portage County, Ohio, two thirds (2/3) or more of the members duly elected thereto concurring;

**SECTION 1.** That Council does hereby authorize fund transfers up to the following amounts to be made by the Village Clerk-Treasurer on a monthly basis for the whole of fiscal year 2012.

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, and to ensure the integrity of the Village finances and further to enable the Clerk Treasurer to track availability of funds to be applied to the semi annual payments on the OWDA debt and OPWC debt, and shall become effective immediately upon proper passage by Council and approval by the Mayor.
