**ORDINANCE 2012-07**

**AN ORDINANCE AMENDING VILLAGE OF MANTUA CODIFIED ORDINANCE  
SECTIONS 955.01(c) AND 955.01(f) RELATING TO GRAVE OPENING AND CLOSING  
COSTS.**

**WHEREAS**, the Board of Cemetery Trustees has recommended an increase of fifty dollars for opening and closing of graves, and an increase of fifty dollars for evening/weekend openings/closings of graves at the Mantua Hillside Cemetery; and

**WHEREAS**, this Council now wishes to amend Sections 955.01(c) and 955.01(f) of the Codified Ordinances of the Village of Mantua in order to address this recommendation.

**NOW THEREFORE**, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring that:

**SECTION 1:** Existing Section 955.01(c) of the Village of Mantua Codified Ordinances is hereby repealed.

**SECTION 2:** Section 955.01(c) of the Village of Mantua Codified Ordinances is hereby enacted as follows:

(c) <u>Grave Opening/Close.</u>		
Adult	\$ 250.00	\$ 450.00
Child Vault - 3 foot long	\$ 150.00	\$ 250.00
Child Vault - 4 foot long	\$ 200.00	\$ 350.00
Disinter/Re-inter same grave	\$1,000.00	\$1,500.00
Disinter/Re-inter new grave	\$1,400.00	\$2,000.00

**SECTION 3:** Existing Section 955.01(f) of the Village of Mantua Codified Ordinances is hereby repealed.

**SECTION 4:** Section 955.01(f) of the Village of Mantua Codified Ordinances is hereby enacted as follows:

(f) Additional Charges. An additional two hundred dollars (\$200.00) shall be charged for burials after 3:30 p.m., Monday through Friday and any time on Saturday, holidays or for special request when granted.

**SECTION 5:** All other provisions of the Village of Mantua Codified Ordinances, including the remaining sections of Section 955.01, shall remain in full force and effect.

**SECTION 6:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 7:** This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
