**ORDINANCE 2012-25**

*(amended)*

**AN ORDINANCE TO REFLECT THE CURRENT SALARIES AND WAGES OF ALL CURRENT FULL TIME AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA TO BE RETROACTIVELY EFFECTIVE MAY 1, 2012, REPEALING ALL PRIOR INCONSISTENT ORDINANCES, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED** by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

**SECTION 1:** Ordinance 2011-83, previously establishing salaries and wages of current employees, is hereby repealed.

**SECTION 2:** The position of Village Administrator is hereby amended from part-time to full-time, effective May 1, 2012.

**SECTION 3:** The compensation rates of all current Village employees are hereby established as follows:

**SECTION 4:** The wage freeze enacted in 2007 for 2008 forward remains in effect. In addition, all employees are frozen in their current position on the pay schedule including longevity until further notice. If increases are warranted for individual employees, their supervisor shall submit recommendation to council for consideration. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance is hereby declared an emergency measure in order to establish compensation rates for the current employees of the Village, particularly the Village Administrator, whose position has been changed to full-time, as of May 1, 2012, and shall become effective immediately upon its passage by Council and approval by the Mayor, and to further ensure the health, safety and morals of the Village of Mantua.
