**ORDINANCE 2012-33**  
**(amended)**

**AN ORDINANCE ESTABLISHING THE POSITION AND PAY SCALE OF A LIEUTENANT WITHIN THE MANTUA POLICE DEPARTMENT AND REPEALING ORDINANCE 2011-71 IN ORDER TO REFLECT THE CURRENT PAY SCALES AND POSITIONS OF ALL NEWLY-HIRED FULL TIME AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Mantua Village Safety Committee has recommended to Council that the position of Lieutenant be established within the Mantua Police Department; and

**WHEREAS**, a Lieutenant of Police is deemed necessary by Council to ensure the efficient administration of the Police Department of the Village of Mantua; and

**WHEREAS**, the establishment of a new position of employment within the Village requires enactment of replacement legislation for the pay scales of newly-hired employees.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

**SECTION 1:** The position of Lieutenant is hereby established within the Village of Mantua Police Department.

**SECTION 2:** Ordinance 2011-71, and all other prior inconsistent Ordinances establishing pay scales and positions for newly-hired employees, is hereby repealed.

**SECTION 3:** Effective immediately, the following positions and compensation rates of newly-hired or promoted Village employees be and are hereby established.

**SECTION 4:** The above wages are established for any newly hired personnel, and shall not be construed to alter the wage freeze in effect for current employees of the Village of Mantua.

**SECTION 5:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 6:** This ordinance is hereby declared an emergency measure in order to establish the position and compensation rate of a Lieutenant in the Mantua Police Department at the earliest possible date, and shall become effective immediately upon its passage by Council, and to further ensure the health, safety and morals of the Village of Mantua.
