

**Village of Mantua, Ohio**  
**ORDINANCE 2012-34**

**AN ORDINANCE ENACTING SECTION 139.03 OF THE CODIFIED  
ORDINANCES OF THE VILLAGE OF MANTUA IN ORDER TO CODIFY THE  
VARIOUS RANKS EXISTING WITHIN THE MANTUA POLICE  
DEPARTMENT.**

**WHEREAS**, the Safety Committee has recommended the establishment of Lieutenant within the Police Department; and

**WHEREAS**, by enacting Ordinance 2012-33, which establishes the current positions of employment within the Village, the position of a Lieutenant of Police has been created; and

**WHEREAS**, the Solicitor has recommended codifying the various positions within the Police Department in order to ensure clarity and consistency.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Mantua, amajority or more of the members elected thereto concurring that:

**SECTION 1.** That Section 139.01 of the Codified Ordinances of the Village of Mantua is hereby amended as follows:

139.03 COMPOSITION.

- (a) The following positions are authorized within the Police Department of the Village of Mantua, who shall perform the duties prescribed by law and ordinance.
- (1) A full-time Chief of Police.
  - (2) A Lieutenant of Police.
  - (3) A Sergeant of Police.
  - (4) One or more Auxiliary Officers.-
  - (5) A full-time Head Dispatcher
  - (6) One or more Part-Time Dispatchers
  - (7) A Cleaning Person
- (b) The positions of Lieutenant and Sergeant may be held by auxiliary officers. Appointment or promotion of officers to these positions shall be subject to approval by Council pursuant to the relevant sections of Ordinance 2010-24 as enacted and subsequently amended.

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance shall become effective after its passage by this Council at the earliest time permitted by law.
