A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR, AND DECLARING AN EMERGENCY.

- **WHEREAS**, This Council in accordance with the relevant provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2013; and
- **WHEREAS**, The Budget Commission of Portage County, Ohio has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill tax limitation; and
- **WHEREAS**, This Resolution must be passed prior to the October 1st, 2012 deadline for certifying the necessary tax levies to the office of the Auditor of Portage County.
- **NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring that:
- **SECTION 1**: The amounts and rates, as determined by the Portage County Budget Commission in its certification, are hereby accepted.
- **SECTION 2**: There be and is hereby levied on the tax duplicate of the Village of Mantua the rate of each tax necessary to be levied within and without the ten mill limitation as set forth in Exhibit "A", attached hereto and incorporated herein by reference.
- **SECTION 3**: The Clerk of this Council is hereby directed to certify a copy of this Resolution to the County Auditor of Portage County prior to October 1st, 2012.
- **SECTION 4**: It is hereby found and determined that all formal action of this Council concerning and relating to the passage if this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in a meeting open to the public is compliance with all legal requirements, including section 121.22 of the Ohio Revised Code;
- **SECTION 5**.; This Resolution is hereby declared to be an emergency measure, effective immediately upon its passage, in order for the Village to meet the County Auditor's deadline of October 1st, 2012, and further to continue the usual daily services necessary for the preservation of the public health, peace, safety and welfare of the community, and to comply with the limitations set forth in ORC 5706.34.
