**AN ORDINANCE AMENDING SECTION 305.09 AND 305.10 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MANTUA, RELATING TO PARKING ON VILLAGE STREETS.**

**WHEREAS,** It has been recommended by the Safety Committee that Sections 305.09 and 305.10 of the Codified Ordinances of the Village of Mantua, relating to Parking on the streets of the Village of Mantua, be amended; and

**WHEREAS,** this Council wishes to address this concern by amending Sections 305.09 and 305.10 of the Codified Ordinances of the Village of Mantua.

**NOW THEREFORE,** be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring that:

**SECTION 1:** Existing Sections 305.09 and 305.10 of the Village of Mantua Codified Ordinances are hereby repealed.

**SECTION 2:** Sections 305.09 and 305.10 of the Mantua Codified Ordinances are hereby enacted as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

**SECTION 3:** All other provisions of the Codified Ordinances of the Village of Mantua, including the remaining sections of Chapter 305, shall remain in full force and effect.

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance shall take effect and be in full force from and after passage by Council and execution by the Mayor, at the earliest date allowed by law, to preserve the Public health, peace, safety, and welfare within the whole of the Village.

**"EXHIBIT A"**

**305.09 PROHIBITED AND RESTRICTED PARKING AREAS.**

- (a) Parking or standing is prohibited on the following streets:

Ambler Lane  
Canada Road  
Coldbrook Drive  
Fernway Drive  
Glenwood Drive (see exemptions)  
Grand Elm Drive  
Line Street  
Mats Road  
Mill Street  
Oak Street  
Park Street  
Peck Road  
Reservoir Drive  
Second Street  
Sontag Lane  
Cemetery Drive (see exemptions)

- (b) Restricted parking is permitted in the following areas on the following streets:

Bramley Drive.	South side only, on or off pavement
Elm Street.	High St. to Regan St.: West side, on or off pavement, except where posted.
First Street.	Prospect St. to High St.: East side, paved areas outside travel portion
Franklin Street.	(See exemptions) Main to Maple St.: Both sides, off pavement only Maple to Elm St.: South side, off pavement only Elm to Oak St.: South side, paved areas outside travel portion Main to First St.: Both sides, paved areas outside travel portion First St. to Second St.: North side, paved areas outside travel portion Second to E. Prospect St.: South side, off pavement
Herald Street.	(See exemptions)

Prospect to Franklin: Both sides, outside travel portion  
Franklin to High: no parking except for exemptions  
High to Walnut: East side, outside travel portion only  
Walnut to Woodford: East side, pavement only

High Street.	(See Exemptions) Main to Maple: Both sides, off travel portion only Main to First: Both Sides, off travel portion South side from 4736 to Cuyahoga River: paved areas outside travel portion only North side at baseball fields, outside travel portion only North side from Cuyahoga River to 200 feet east, outside travel portion only
Main Street.	East side from High St. to Prospect St. West side from Franklin St. to Prospect St. East side between Cuyahoga River Bridges
Maple Street.	High to Franklin: West side, off pavement Franklin to Prospect: West side, on pavement
Orchard Street	South sides, off travel portion only
Prospect Street.	(See Exemptions) Cemetery Dr. to Elm: South side, on or off pavement Elm to Maple: South side, off pavement only Maple to Main: Both sides, on pavement Main to 50 feet past First St.: South side, on pavement 50 feet past First St. to High: No parking either side
Regan Street.	Prospect to curve: East side, off pavement only 4596 to Elm: South side off travel portion Elm to Line: Both sides, off travel portion
Walnut Street.	North side from Main St. to Herald St., off travel portion only
Woodford Street.	North side from Main St. to Herald St., off travel portion only

Parking in all other areas of streets listed in subsection (b) hereof is prohibited.

- (c) Parking is prohibited on the following streets between the hours of 3:00 a.m. and 6:00 a.m.

Prospect Street from Second St. to Maple St.

First Street from Prospect St. to Franklin St.

- (d) Parking is limited on the following streets or portions of streets to a 2 hour parking between the hours of 8:00 a.m. and 7:00 p.m.:

East side of Main Street from High St. to Prospect St.

West side of Main Street from Franklin St. to Prospect

Prospect Street from Maple St. to First St.

- (e) The Village Administrator is hereby directed to install and maintain signs and mark the streets by painting in accordance with the Uniform Traffic Manual as adopted by the Ohio Department of Transportation. (Ord. 2007-38. Passed 12-18-07.)

**305.10 EXEMPTIONS.**

- (a) The Village recognizes the need to exempt certain areas of this chapter to allow parking on those areas which have been prohibited. Only the areas listed below are exempt:

Cemetery Drive	South side only at 10662 Line St. address
Franklin Street	Only at 4486, 4489
Glenwood Drive	Only at 4733
Herald Street	West side only at 4726 High St. address East side only at 4732 High St. address, single vehicle only
High Street	West side only at 10702 South side only at 4488, 4494, 4500, 4550, 4556 and 4736
Prospect Street	Only at 4437, 4565 and 4571
Maple Street	East side at 10714 and 10720, off travel portion

- (b) The Mayor or Chief of Police may upon request of a Village resident grant parking for special or unusual events for limited time in no parking zone areas.
- (c) The provision of this section shall not apply to authorized public safety or emergency vehicles, public utilities vehicles, street and service department vehicles while in use for Village purposes.
- (d) A property owner may petition the Village of Mantua in writing for consideration of parking in the right-of-way upon proof of need and a copy of specifications of the approved area to be installed. (Ord. 2007-38. Passed 12-18-07.)
