Village of Mantua, Ohio ORDINANCE 2012-72

AN ORDINANCE ESTABLISHING THE CURRENT PAY SCALES AND POSITIONS OF ALL NEWLY-HIRED FULL TIME AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA, REPEALING PRIOR INCONSISTENT ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, the Mantua Village Safety Committee has recommended to Council that the position of part time police officers be established, and the Auxiliary police unit amended; and

WHEREAS, the Pay scales of newly hired employees must therefore be amended to reflect an hourly rate for part time police officers, an annual rate for auxiliary officers, and the current upper limits of certain other police department officers and employees.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

SECTION 1: Ordinance 2012-33, and all other prior inconsistent Ordinances establishing pay scales and positions for newly-hired employees, is hereby repealed.

SECTION 2: Effective immediately, the following positions and compensation rates of newly-hired or promoted Village employees be and are hereby established.

SECTION 3: The above wages are established for any newly hired personnel, and shall not be construed to alter the wage freeze in effect for current employees of the Village of Mantua.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance is hereby declared an emergency measure in order to establish the pay rates for part time and auxiliary officers of the Mantua Police Department at the earliest possible date, and shall become effective immediately upon its passage by Council, and to further ensure the health, safety and morals of the Village of Mantua.
