A RESOLUTION AUTHORIZING CERTAIN FUND TRANSFERS BY THE CLERK-TREASURER BETWEEN THE WATER AND SEWER OPERATING FUNDS AND THEIR RESPECTIVE DEBT SERVICE RESERVE FUNDS, NECESSARY TO MEET 2013 DEBT SERVICE REQUIREMENTS, AND DECLARING AN EMERGENCY

**WHEREAS**, the Village is obligated to make semi annual debt service payments to the Ohio Water Development Authority (OWDA) and the Ohio Public Works Commission (OPWC) in June 2013 and December 2013; and

WHEREAS, it is necessary for the Village Council to authorize monthly transfers to accumulate the funds needed to make these debt service payments; and

**WHEREAS**, the Village Council wishes to authorize the necessary transfers for the whole of fiscal year 2013 without taking separate action each month.

**NOW THEREFORE, BE IT RESOLVED**, by the Council of Village of Mantua, Portage County, Ohio, two thirds (2/3) or more of the members elected thereto concurring, that:

**SECTION 1**. Council does hereby authorize fund transfers up to the following amounts to be made by the Village Clerk-Treasurer on a monthly basis for the whole of fiscal year 2013.

**SECTION 3**. This Resolution is hereby declared to be an emergency measure necessary to ensure the integrity of the Village finances and further to enable the Clerk Treasurer to track availability of funds to be applied to the semi annual payments on the OWDA debt and OPWC debt beginning in January, 2013, and shall become effective immediately upon proper passage by Council and approval by the Mayor.
