**RESOLUTION 2013-27**

**A RESOLUTION RATIFYING THE MAYOR'S APPLICATION FOR HIRAM COMMUNITY TRUST GRANT FUNDS AND AUTHORIZING ACCEPTANCE OF SUCH FUNDS FOR THE INSTALLATION OF PLAYGROUND EQUIPMENT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Hiram Community Trust is making funds available for various public purposes; and

**WHEREAS**, the Mayor has applied for Hiram Community Trust funds for the purpose of installing a merry-go-round at Buchert Park; and

**WHEREAS**, this Council wishes to ratify this application and authorize acceptance of the funds should the requested grant funds be awarded to the Village of Mantua.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** The Mayor's application for Hiram Community Trust grant funds in the amount of \$6,674.00 for the installation of playground equipment at Buchert Park is hereby ratified and approved.

**SECTION 2:** The Council of the Village of Mantua hereby authorizes the Clerk-Treasurer to accept the Hiram Community Trust grant monies, in the event that the Village of Mantua's grant application is successful.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Resolution is hereby declared an emergency measure, due to the need to ratify and approve the application for Hiram Community Trust grant monies, which application was due by April 12<sup>th</sup>, 2013, and shall become immediately effective upon its proper passage by two thirds or more of the members elected to this Council.
