**ORDINANCE 2013-45**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2013  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, in order for the General Fund 1000 to transfer funds to the Permissive Funds 2101 and the Sewer Operating Fund 5201 passed by Ordinance 2013-44, the General fund appropriations must be increased by \$35,000; and

**WHEREAS**, in order to complete the Elm St. paving project it is necessary to increase appropriations in the Permissive Fund 2101 by \$10,000; and

**WHEREAS**, in order to purchase the Headwaters Trail “Way Finding” signs and other expenses the appropriations must be increased in the Park Improvement Fund 4903 by \$2,000; and

**WHEREAS**, in order to continue normal operations of the Wastewater Treatment plant the appropriations must be increased in the Sewer Operating Fund 5201 by \$25,000.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustment to the 2013 Village Appropriations:

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to permit payment of the Village’s expenses in a timely manner, to avoid permitting expenditures to exceed appropriations and to maintain correct accounting practices, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
