**ORDINANCE 2013-59**

**AN ORDINANCE TO REFLECT THE CURRENT SALARIES AND WAGES OF ALL  
CURRENT FULL TIME AND PART TIME EMPLOYEES OF THE VILLAGE OF  
MANTUA, REPEALING ALL PRIOR INCONSISTENT ORDINANCES, AND  
DECLARING AN EMERGENCY.**

**WHEREAS**, the Village has hired a new Village Administrator, who must be included in the current Pay Ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

**SECTION 1:** Prior Wage Ordinance 2013-50 and all other inconsistent Ordinances are hereby repealed.

**SECTION 2:** The compensation rates of all current Village employees are hereby established as follows:
