**ORDINANCE 2014-18**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2014  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the General Fund has unappropriated funds that are now needed in order to pay some unexpected income tax refunds, and to support transfers to other funds; and

**WHEREAS**, \$1,214.00 is being transferred to the S.R. 44 Sidewalk Project Fund, which also contains additional unappropriated monies, requiring an increase in appropriations to Fund 4907 in order to meet project obligations; and

**WHEREAS**, \$10,000.00 is being transferred to the Water Operating Fund which must be appropriated in order to pay for upgrades to the plant and well work; and

**WHEREAS**, \$84,000.00 is being transferred to the Sewer Operating Fund which must be appropriated in order to pay for major repairs and upgrades and continue normal operations.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2014 Village Appropriations:

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, and to avoid expenses exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
