ORDINANCE 2014-03

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2014
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, in order to provide for expenses for repairs which will be made to various Village property as a result of the July 10, 2013 flooding, which will be partially funded under the State Disaster Relief Program, appropriations in General Fund #1000 must be increased by \$100,000.00; and

WHEREAS, Capital Reserve fund #4904 has an old balance of \$94.26 which could be appropriated and used towards a capital improvement in 2014, thereafter permitting the Village to close this fund; and

WHEREAS, Water Capital Improvement fund #5761 has unappropriated funds available which will be needed to purchase materials for the Fire Hydrant replacement grant.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustments to the 2014 Village Appropriations:

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
