**RESOLUTION 2014-30**

**A RESOLUTION SUBMITTING TO THE ELECTORS OF THE VILLAGE OF MANTUA THE QUESTION OF AN ADDITIONAL FIVE (5) YEAR 3.85 MILL TAX LEVY FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING AND REPAIR OF STREETS, ROADS AND BRIDGES WITHIN THE VILLAGE, PURSUANT TO OHIO REVISED CODE SECTIONS 5705.19(G) AND 5705.191, AND DECLARING AN EMERGENCY.**

**WHEREAS**, on April 29, 2014, this Council adopted Resolution No. 2014-21 pursuant to Section 5705.03 of the Ohio Revised Code, declaring it necessary to levy an additional tax in excess of the ten-mill limitation amounting to revenue of seventy-five thousand dollars (\$75,000.00) annually for the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the Village, and requesting the Portage County Auditor to certify the total current tax valuation of the Village and the number of mills necessary to generate the stated amount of revenue; and

**WHEREAS**, on April 30, 2014, the Portage County Auditor certified that the total current tax valuation of the Village is \$19,516,210.00, and that the number of mills necessary to produce an additional \$75,000.00 annually during the life of the levy would be 3.85 mills, assuming that the total current tax valuation of the Village remains the same during the life of the levy.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Mantua, State of Ohio, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** This Council finds, determines and declares that the amount of taxes that may be raised by the Village of Mantua within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of this Village, and that it is necessary to levy an additional tax in excess of that limitation at the rate of 3.85 mills for the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the Village for a period of five (5) years.

**SECTION 2.** The question of an additional levy of 3.85 mills for the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the Village, beginning with the tax list and duplicate for the year 2014, the proceeds of which levy first would be due and collected and made available to the Village in calendar year 2015, shall be submitted under the provisions of Sections 5705.191 and 5705.19(G) of the Revised Code to the electors of the Village of Mantua at an election to be held therein on November 4, 2014, as authorized by law. That election shall be held at the regular place of voting in this Village as established by the Board of Elections of Portage County, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law.

**SECTION 3.** The Clerk-Treasurer of the Village of Mantua is hereby authorized and directed to give or cause to be given notice of that election as provided by law.

**SECTION 4.** The Clerk-Treasurer is hereby authorized and directed to certify a copy of this Resolution, together with Resolution No. 2014-21, adopted April 29, 2014, and the related

Certificate of the Portage County Auditor, to the Portage County Board of Elections before the close of business on August 6, 2014.

**SECTION 5.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of the State of Ohio.

**SECTION 6.** This Resolution is hereby declared to be an emergency measure, immediately effective upon passage by at least two-thirds of the members elected to the Mantua Village Council, so that this Resolution may timely filed with the Portage County Board of Elections, in order to submit the question of the additional tax levy to the electors at the election to be held on November 4, 2014, and to further ensure the health safety and welfare of the Village of Mantua.
