**ORDINANCE 2015-11**

**AN ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF MANTUA, OHIO AND DECLARING AN EMERGENCY.**

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Mantua, Ohio;

**WHEREAS**, numerous sections in the Traffic, General Offenses and Fire Prevention Codes need to be amended or enacted so as to conform to State law; and declaring an emergency.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MANTUA, OHIO:**

**SECTION 1.** That the recodification, editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Mantua, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to wit:

**SECTION 4.** That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements, including conflict with general State law, and shall go into effect immediately.
