**ORDINANCE 2015-25**

**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE EASEMENTS  
RELATING TO THE HIGH STREET BRIDGE PROJECT, AND DECLARING AN  
EMERGENCY.**

**WHEREAS**, temporary and permanent easements are required in furtherance of the reconstruction of the High Street Bridge over the Cuyahoga River within the Village limits; and

**WHEREAS**, this Council wishes to authorize the Mayor to execute all necessary instruments to complete this project for the health, safety and welfare of the inhabitants of the Village of Mantua.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of all members elected thereto concurring, that:

**SECTION 1:** The Mayor is hereby authorized and directed to execute Perpetual Easements for Highway Purposes in substantially the same form as Exhibit A [Parcel 1-SH]; Exhibit C [Parcel 2-SH] and Exhibit D [Parcel 4-SH], attached hereto and incorporated herein by reference.

**SECTION 2:** The Mayor is hereby authorized and directed to execute Temporary Work Easements to Portage County in substantially the same form as Exhibit B [Parcel 1-T] and Exhibit E [Parcel 4-T], attached hereto and incorporated herein by reference.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning a relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance is hereby declared an emergency measure, effective immediately upon its passage, in order to expedite the bidding and construction process for the High Street Bridge Replacement Project, and to further ensure the health, safety and welfare of the inhabitants of the Village of Mantua.
