ORDINANCE 2015-30

AN ORDINANCE ESTABLISHING PAY SCALES AND POSITIONS OF FULL AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA RETROACTIVE TO JULY 21, 2015, REPEALING PRIOR INCONSISTENT ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, at its regular monthly meeting on July 21, 2015, this Council authorized the Village Administrator to conduct interviews for and hire a part-time administrative assistant; and

WHEREAS, the “Pay Scales and Positions” Ordinance must now be amended in order to address the newly created position.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: Ordinance 2015-24 establishing pay scales and positions for Village employees is hereby repealed.

SECTION 2: The wage freeze enacted in 2007 remains lifted.

SECTION 3: Longevity pay remains frozen and employees currently receiving longevity pay will not receive additional longevity pay should their base hourly rate be raised.

SECTION 4: Merit raises from current rates within the ranges listed below may only be granted upon recommendation of the Department Head to the Mayor and the Mayor’s written approval.

SECTION 5: Any raises outside of the ranges listed below must be approved by Council.

SECTION 6: Effective immediately, the following positions and compensation ranges of full and part time Village employees, where such positions and compensation are not provided for in separate legislation, are hereby established:

SECTION 7: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 8: This Ordinance is hereby declared a retroactive emergency measure, effective July 21, 2015, in order to immediately permit the Service Department Administrative Assistant to be paid as authorized by this Council, and shall become effective immediately upon its passage by at least two-thirds of the members elected to the Mantua Village Council.
