**RESOLUTION 2015-39**

**ADOPTION OF 2016 CALENDAR, AND DECLARING AN EMERGENCY.**

**BE IT RESOLVED**, by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** Regular meetings of the Village of Mantua Council shall be held at seven p.m. eastern standard time or daylight savings time (whichever standard of time is in effect in the Village of Mantua, Ohio at the time of such meeting) in the months of January, February, March, April, May, June, July, August, September, October, November, and December, on the third Tuesday of the month as is set forth in section (2) hereof. The regular meetings shall also be advertised at the permanent principal place of business at the Village Hall. Pursuant to Section 121.03 of the Codified Ordinances of the Village of Mantua, and subject to all relevant provisions of law, regular meetings may be held at another time or location within the Village.

**SECTION 2:** The Village Council adopts the following calendar, at the following times and places for its 2016 regular meeting schedule:

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Resolution is hereby declared an emergency measure, effective immediately upon proper passage by this Council, in order that the 2016 Council calendar may be effective on January 1, 2016.
