ORDINANCE 2016-11

**AN ORDINANCE ESTABLISHING A RENTAL FEE SCHEDULE FOR THE VILLAGE
PARK LODGE AND ALLOCATING A PORTION OF THOSE FEES TO THE PARK
CAPITAL IMPROVEMENT FUND #4903**

WHEREAS, the Finance Committee has recommended updating the fee schedule for rentals of the village park lodge building in order to cover operational expenses; and

WHEREAS, the Finance committee has further recommended that a portion of the fee should be allocated to the Park Capital Improvement Fund #4903 for the purpose of improvements to the park and updating aged playground equipment.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: The park lodge rental fee schedule is hereby established as set forth in “Exhibit A”, attached hereto and incorporated herein by reference, and shall be included in the park lodge rental agreement.

SECTION 2: A portion of each park lodge rental fee shall be allocated to the Park Capital Improvement Fund #4903 pursuant to the schedule set forth in “Exhibit B”, attached hereto and incorporated herein by reference.

SECTION 3: Allocation of funds will be calculated and transferred at the end of each month after all park rental monies have been recorded.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance shall be effective after passage by at least a majority of the members elected to the Mantua Village Council at the earliest period allowed by law.
