RESOLUTION 2016-13

A RESOLUTION RESCINDING RESOLUTION 2016-09 AND AUTHORIZING THE MAYOR OF THE VILLAGE OF MANTUA TO APPLY FOR AN OHIO DEPARTMENT OF NATURAL RESOURCES RECREATIONAL TRAILS PROGRAM GRANT WHICH INCLUDES FUNDING TO EXTEND THE HEADWATERS TRAIL BY WAY OF A RAMP TO MENNONITE ROAD, AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Natural Resources, as administrative agent for the Recreational Trails Program (RTP) Grant, is making funds available for various public purposes; and

WHEREAS, this Council previously passed Resolution 2016-09, authorizing application for the aforementioned funding in order to resurface the Village's portion of the trail, but now deems it appropriate to include a request for funding which would enable the Village to also extend the Headwaters Trail to Mennonite Road by way of a ramp.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring that:

SECTION 1. Resolution 2016-09, passed March 15, 2016, is hereby rescinded.

SECTION 2. The Mayor is hereby authorized to execute and submit an application for the Recreational Trails Program grant for improvements to the Village of Mantua Headwaters Trail including resurfacing the Village of Mantua's portion thereof with a new limestone base and to extend the Trail to Mennonite Road by way of a ramp.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is declared an emergency measure, in order to permit application for this funding opportunity prior to the application deadlines, and shall become effective immediately upon its passage by Council and approval by the Mayor, and to further ensure the health, safety, and morals of the Village of Mantua.
