**ORDINANCE 2016-36**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2016  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the General fund appropriations must be increased in order to have funds available to advance to the Headwaters Trail Mill St. Connector project; and

**WHEREAS**, the Street Operating fund appropriations must be increased in order to have funds available for Oak and Franklin street paving and storm sewer improvements; and

**WHEREAS**, once those funds are advanced in to the Headwaters Trail Mill St. Connector fund, appropriations must be increased in order to have funds available to pay invoices related to the Headwaters Trail Mill St. Connector project pursuant to the Clean Ohio grant, through which expenditures will be reimbursed by ODNR as submitted at 80%.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2016 Village Appropriations:

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
