ORDINANCE 2016-47

**AN ORDINANCE AMENDING VILLAGE OF MANTUA CODIFIED ORDINANCES
SECTIONS 921.04 AND 931.03 RELATING TO NON-VILLAGE CHARGES FOR
WATER AND SEWER.**

WHEREAS, the Service Committee has recommended amendment of sections 921.04 and 931.03 of the Codified Ordinances of the Village of Mantua in order to clarify the charges for customers of the Village's water and sanitary sewer systems outside of the Mantua Village municipal boundaries; and

WHEREAS, this Council now wishes to amend sections 921.04 and 931.03 of the Codified Ordinances of the Village of Mantua in order to address this recommendation.

NOW THEREFORE, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring, that:

SECTION 1: Existing sections 921.04 and 931.03 of the Codified Ordinances of the Village of Mantua are hereby repealed.

SECTION 2: Section 921.04 of the Codified Ordinances of the Village of Mantua is hereby enacted as follows:

921.04 NON-VILLAGE CHARGE.

Customers of the Village's water system outside the Mantua Village municipal boundaries shall be charged one hundred and twenty-five percent (125%) of the charges outlined in Section 921.02 and one hundred and fifteen percent (115%) of the charges outlined in Section 921.03.

SECTION 3: Section 931.03 of the Codified Ordinances of the Village of Mantua is hereby enacted as follows:

931.03 NON-VILLAGE CHARGE.

Customers of the Village's sanitary sewer system outside the Mantua Village municipal boundaries shall be charged one hundred and twenty-five percent (125%) of the charges outlined in Section 931.01 and one hundred and fifteen percent (115%) of the charges outlined in Section 931.02.

SECTION 4: All other provisions of the Village of Mantua Codified Ordinances, including the remaining sections of Chapters 921 and 931, shall remain in full force and effect.

SECTION 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
