**ORDINANCE 2016-05**

**AN ORDINANCE AMENDING SECTION 173.07 OF THE CODIFIED ORDINANCES  
OF THE VILLAGE OF MANTUA REGARDING QUARTERLY ESTIMATED  
PAYMENTS OF MUNICIPAL INCOME TAX.**

**WHEREAS**, pursuant to Ohio Revised Code section 718.08(F)(2), a municipal corporation may, by ordinance or rule, waive the requirement for filing a declaration of estimated taxes for all taxpayers; and

**WHEREAS**, the Mantua Village Finance Committee has recommended that the requirement for filing a declaration of estimated taxes be waived for all taxpayers; and

**WHEREAS**, Section 173.07 of the Mantua Village Codified Ordinances must be amended in order to address this recommendation.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Mantua, Ohio, a majority or more of the members elected thereto concurring, that:

**SECTION 1.** Existing section 173.07 of the Codified Ordinances of the Village of Mantua is hereby repealed.

**SECTION 2.** Section 173.07 of the Codified Ordinances of the Village of Mantua is hereby enacted as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance shall become effective after its passage by Council, at the earliest period allowed by law.

**“EXHIBIT A”**

**173.07            DECLARATION OF ESTIMATED TAX**

- (a) Pursuant to the authority granted under Ohio Revised Code section 718.08(F)(2), the Council of the Village of Mantua hereby waives the requirement for filing a declaration of estimated taxes for all taxpayers.
- (b) Any taxpayer may make voluntary filing and payment of estimated taxes on a quarterly basis, and such filing shall be made using forms prescribed by the Tax Administrator.
