**ORDINANCE 2017-09**

**AN ORDINANCE AMENDING SECTION 941.17(n)(4) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MANTUA, RELATING TO INSTALLATION OF WATER METERS AND RELATED EQUIPMENT.**

**WHEREAS**, the Village of Mantua Service Committee has recommended an amendment to Section 941.17(n)(4) of the Codified Ordinances of the Village of Mantua, relating to installation of water meters and remote registers.

**NOW THEREFORE**, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring, that:

**SECTION 1:** Existing Section 941.17(n)(4) of the Codified Ordinances of the Village of Mantua is hereby repealed.

**SECTION 2:** Section 941.17(n)(4) of the Codified Ordinances of the Village of Mantua is hereby enacted as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

**SECTION 3:** All other provisions of the Codified Ordinances of the Village of Mantua shall remain in full force and effect, including the remaining provisions of Section 941.17(n).

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance shall be in full force and effect after passage by at least a majority of the members elected to the Mantua Village Council at the earliest period allowed by law.

**“EXHIBIT A”**

(n) Meters....

(4) Existing meters and registers that do not meet the specifications of the Village Administrator shall be replaced at the expense of the owner. If the Village Administrator deems it a simple installation/re-installation, the Village of Mantua will install the meter and remote register. Where there is an existing approved meter that will accommodate a remote register, said register will be required to be installed by qualified personnel, or if deemed by the Village Administrator a simple installation, by the Village of Mantua, at the expense of the owner and title thereto be assigned to the Village.
