**ORDINANCE 2018-12**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2018  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the General fund requires \$36,000 to be appropriated in order to make an advance to the Buchert Park Walking Trail fund in order to finance this project until reimbursed by Ohio Department of Natural Resources and also for additional UAN fees; and

**WHEREAS**, the Road and Bridge Levy fund carryovers can now be appropriated to be used towards the local match for the W. Prospect St. Roadway project and for election expenses related to placing the levy renewal on the November 6 ballot; and

**WHEREAS**, the West Prospect St. Roadway and Drainage fund 4204 appropriations must be reduced by \$150,000 because the local match will be paid for out of the Road and Bridge Levy fund and Permissive funds; and

**WHEREAS**, appropriations in the Police Capital Fund 4902 must be increased by \$6,000 to pay for new 911 phone equipment.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2018 Village Appropriations:

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
