## Village of Mantua, Ohio **ORDINANCE 2019-05**

## AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2019 APPROPRIATIONS AND DECLARING AN EMERGENCY.

**WHEREAS**, appropriations in the W. Prospect St. Roadway fund must be increased to record the "Pass-Through" payments that will be made by Ohio Public Works Commission; and

**WHEREAS,** appropriations in the Water Operating fund 5101, and the Water Capital Improvement fund 5761 must be increased for expenditures relating to the Reservoir Improvements; and

**WHEREAS**, appropriations in the Sewer Capital Improvement fund 5762 must be increased for capital improvements relating to the wastewater treatment plant.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:
