**RESOLUTION 2019-40**

**A RESOLUTION AUTHORIZING THE CLERK OF THE VILLAGE OF MANTUA TO CERTIFY MOWING CHARGES TO THE PORTAGE COUNTY AUDITOR'S OFFICE TO BE PLACED AS AN ASSESSMENT ON THE LISTED PARCEL NUMBERS AND DECLARING AN EMERGENCY.**

**WHEREAS**, Village of Mantua Codified Ordinances Section 909.03, relating to the cutting and removal of weeds or vegetation, authorizes the assessment of unpaid mowing charges to the Office of the County Auditor for placement on the tax duplicate relating to the property where such charges were incurred; and

**WHEREAS**, the Village of Mantua has incurred charged in the total amount of \$400.00 for the cutting of grass and weeds to be divided equally (\$200.00 on each parcel) on Portage County Permanent Parcel Numbers 24-041-14-00-029-000 and 24-041-14-00-030-000, which remain unpaid as set forth in the attached "Exhibit A"; and

**WHEREAS**, the Mantua Village Administrator has recommended that such charges be certified to the Portage County Auditor for placement on the tax duplicate as permitted by law.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Mantua, two thirds or more of the members elected thereto concurring, that:

**SECTION 1.** This Council hereby finds that the procedure set forth in Section 909.03 of the Codified Ordinances of the Village of Mantua has been followed and that the mowing charges set forth in the attached "Exhibit A", attached hereto and incorporated herein by reference, are now delinquent and shall be certified to the Portage County Auditor for placement on the tax duplicate as permitted by law.

**SECTION 2.** The Clerk-Treasurer of the Village of Mantua is hereby authorized and directed to certify the mowing charges set forth in attached "Exhibit A" to the Portage County Auditor's Office to be placed as an assessment against the listed parcels.

**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Resolution is hereby declared to be an emergency measure in order for the Village of Mantua to certify the amounts indicated to the Portage County Auditor prior to the September 9, 2019 deadline for such certifications, wherefore, this Resolution shall be in full force and effect immediately upon its proper passage by Council.
