

**Village of Mantua, Ohio**  
**ORDINANCE 2021-13**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2021  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, an open purchase order from 2020, encumbering funds for the West Prospect St. Roadway Project, has caused the Road and Bridge Fund 2012 to be over-appropriated for 2021; and

**WHEREAS**, according to the Portage County Auditor's Certificate of Estimated Resources, the village has over-appropriated monies in the Buchert Park Walking Trail fund 4201; and

**WHEREAS**, appropriations in these funds must be reduced in order to prevent appropriations from exceeding estimated resources.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2021 Village Appropriations:

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent appropriations from exceeding estimated resources, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
