Village of Mantua, Ohio **ORDINANCE 2021-32**

AN ORDINANCE AMENDING SCHEDULE 305.02 AND SECTION 400.01.F OF THE ZONING ORDINANCES OF THE VILLAGE OF MANTUA RELATING TO AGRICULTURAL USES.

WHEREAS, the Planning Commission has conducted a review of the regulations controlling agricultural uses in the Village of Mantua, and has recommended that "Agriculture" be made a conditional use in the R-1 and R-2 Zoning Districts, and that roosters be prohibited in all districts; and

WHEREAS, this Council wishes to amend Schedule 305.02 and Section 400.01.F of the Zoning Ordinances of the Village of Mantua in order to address this recommendation.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, a majority or more of the members elected thereto concurring, that:

SECTION 1. Existing Schedule 305.02 of the Zoning Ordinances of the Village of Mantua is hereby amended in order to make "Agriculture" a conditional use in the R-1 and R-2 Zoning Districts, as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

SECTION 2. Section 400.01.F.5 of the Zoning Ordinances of the Village of Mantua is hereby enacted as follows:

- 5. No person shall keep any rooster within the Village, except in the Rural Residential Zoning District.
- **SECTION 3.** All other provisions of the Zoning Ordinances of the Village of Mantua shall remain in full force and effect.
- **SECTION 4.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 5. This Ordinance shall become effective after public hearing and approval by this Council and at the earliest period allowed by law.
