AN ORDINANCE AMENDING SECTION 305.09(b) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MANTUA, IN ORDER TO CLARIFY PARKING ON EAST HIGH STREET.

WHEREAS, it has been recommended by the Safety Committee that Section 305.09(b) of the Codified Ordinances of the Village of Mantua be amended, in order to restrict parking on the south side of East High Street near its intersection with Main Street.

NOW THEREFORE, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring, that:

SECTION 1: Existing Section 305.09(b) of the Village of Mantua Codified Ordinances is hereby repealed.

SECTION 2: Section 305.09(b) of the Village of Mantua Codified Ordinances is hereby enacted as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

SECTION 3: All other provisions of the Codified Ordinances of the Village of Mantua, including the remaining sections of Chapter 305.09, shall remain in full force and effect.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance shall take effect and be in full force from and after passage by Council and execution by the Mayor, at the earliest date allowed by law, to preserve the Public health, peace, safety, and welfare within the whole of the Village.

305.09(b) Restricted parking is permitted in the following areas on the following streets:

Elm Street.	<i>Prospect Street to Regan St.: West side, on or off pavement</i>
First Street.	<i>Prospect St. to High St.: East side, paved areas outside travel portion</i>
Franklin Street.	<i>(See exemptions)</i> <i>Main to Maple St.: Both sides, off pavement only</i> <i>Maple to Elm St.: South side, off pavement only</i> <i>4562 Franklin to Oak St.: South side, paved areas outside travel portion</i> <i>Main to First St.: Both sides, paved areas outside travel portion</i> <i>First St. to Second St.: North side, paved areas outside travel portion</i> <i>Second to E. Prospect St.: South side, off pavement</i>
Herald Street.	<i>(See exemptions)</i> <i>Prospect to Franklin: Both sides, outside travel portion</i> <i>Franklin to High: no parking except for exemptions</i> <i>High to Walnut: East side, outside travel portion only</i> <i>Walnut to Woodford: East side, pavement only</i>
High Street.	<i>(See Exemptions)</i> <i>Main to Maple: Both sides, off travel portion only</i> <i>Main to First: North Side, off travel portion;</i> <i>South Side, off travel portion beginning 52 feet east of crosswalk</i> <i>South side from 4736 to Cuyahoga River: paved areas outside travel portion only</i> <i>North side at baseball fields, outside travel portion only</i> <i>North side from Cuyahoga River to 200 feet east, outside travel portion only</i>
Main Street.	<i>East side from High St. to Prospect St.</i> <i>West side 20 feet south of Franklin St. to Prospect St.</i> <i>East side between Cuyahoga River Bridges, off pavement</i>
Maple Street.	<i>Franklin to Prospect: West side, on pavement</i>
Orchard Street	<i>South sides, off travel portion only</i>
Prospect Street.	<i>(See Exemptions)</i> <i>4516 Prospect to Elm: South side, on or off pavement</i> <i>Elm to Regan: South side, off pavement only</i>

Maple to Main: Both sides, on pavement
Main to east side 4680 Prospect St.: South side, on pavement
50 feet east of First St. to High: No parking either side
*15 minute parking only in marked space at West side of
4690 Prospect*

Regan Street. 4596 to Elm: South side off travel portion-

Walnut Street. North side from Main St. to Herald St.,
off travel portion only

Woodford Street. North side from Main St. to Herald St.,
off travel portion only

Parking in all other areas of streets listed in subsection (b) hereof is prohibited.
