

**Village of Mantua Ohio
ORDINANCE 2022-40**

**AN ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION
OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES
OF THE CODIFIED ORDINANCES OF MANTUA, OHIO
AND DECLARING AN EMERGENCY.**

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Mantua, Ohio;

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be amended or enacted so as to conform to State law; and declaring an emergency.

NOW, THEREFORE, be it Ordained by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. The recodification, editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Mantua, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to wit:

SECTION 3. The complete text of the Traffic and General Offenses Code sections listed above are set forth in full in the 2022 replacement pages to the Codified Ordinances which are hereby attached to this ordinance as Exhibit A. Any summary publication of this ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements, including conflict with general State law, and shall go into effect immediately upon proper passage by the Mantua Village Council.
