

**Village of Mantua, Ohio**  
**ORDINANCE 2022-52**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2022  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, appropriations in Street Maintenance Fund 2011 must be increased in order to be sufficient to pay for 2022 expenses, including increased gasoline and medical benefit expenses; the new appropriation does not exceed the beginning fund balance (\$73,335.48) plus projected revenue for 2022 (\$91,677.26); and

**WHEREAS**, when Cemetery Fund 2031 Appropriations were increased by Ordinance 2022-28, the appropriation amendment was erroneously based only on only one line item of the fund, rather than the entire fund. Appropriations must now be increased to reflect available resources in the entire fund; and

**WHEREAS**, appropriations in American Rescue Plan Act Fund 2151 must be reduced in order to correct a minor discrepancy with the County Budget Commission's Amended Certificate of Estimated Resources; and

**WHEREAS**, appropriations in Capital Projects Fund 4905 must be increased because no funds were previously appropriated into this fund for 2022, but the fund had an actual balance of \$42,500.00, which has been used to pay for this year's paving on Canada Rd., bringing the fund balance to zero and allowing it to be closed as required by Ordinance 2013-15.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2022 Village Appropriations:

**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
