- ❖ Drones- Two sample ordinances included in packet. With them becoming more popular Chief feels some type of regulation needs to be set. Concerns with crashing in crowds, etc. Don't want to stop them. Notification needs to be made to Village so we are aware. Committee discussed and agreed to table and review information provided.

NEW BUSINESS CON'T:

- ❖ Mandated Training- The State of Ohio is now requiring 16 hours of continuing training for officers instead of 4 hours. This requires Officers to attend classes as provided thru OPOTA in either Richfield or London. We are required to pay for officers hours and the current budget will not allow for this. We are reimbursed at the end of the year. All officers have met this years requirements.
- ❖ SRO Funding- Chief is asking for the remaining SRO funding from cost to go back to Police Capital. Committee discussed and agreed. Bill made motion to move for money to go back to Police Capital as requested, Marty 2nd the motion, all ayes.
- ❖ Comments: Chief shared a letter with Committee from Crestwood High School Assistant Principal reference K9 Diablo and Ptl. Urso.
