ORDINANCE 2011-13

**AN ORDINANCE AMENDING VILLAGE OF MANTUA CODIFIED ORDINANCE
SECTION 921.02 TO INCLUDE RATES FOR "BULK WATER".**

WHEREAS, the Village of Mantua Service Department has recommended amending Village of Mantua Codified Ordinance Section 921.02 in order to establish rates for bulk water; and

WHEREAS, this Council now wishes to amend Section 921.02 of the Codified Ordinances of the Village of Mantua in order to address this recommendation.

NOW THEREFORE, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring that:

SECTION 1: Existing Section 921.02 of the Village of Mantua Codified Ordinances is hereby repealed.

SECTION 2: Section 921.02 of the Village of Mantua Codified Ordinances is hereby enacted as follows:

921.02 WATER USAGE RATES.

- (a) Rates for water usage within the Village are as follows:

SECTION 3: All other provisions of the Village of Mantua Codified Ordinances shall remain in full force and effect.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
