**ORDINANCE 2011-24**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2011  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Council of the Village of Mantua has determined that previously appropriated funds must be adjusted in order to continue operations in the Village; and

**WHEREAS**, the Village of Mantua is the recipient of an Ohio Public Works Commission grant for an emergency well pump replacement; and

**WHEREAS**, the funds are currently available to expend on this project and Council wishes to appropriate funds to pay for expenses related to the replacement of the well pump and the engineering services involved; and

**WHEREAS**, the Water Capital Improvement Fund 5761 also has funds available to appropriate that are currently needed for the Village matching funds for the Emergency Well Pump Replacement grant, and also a major computer repair (SKADA system).

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring:

**SECTION 1.** Council does hereby authorize the following adjustment to the 2011 Village Appropriations:

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to conduct emergency repairs relating to to the water treatment and supply system of the Village, and for that reason this Ordinance shall take effect immediately upon its passage.
