**RESOLUTION 2013-36**

**A RESOLUTION RETROACTIVELY APPROVING A DEVIATION FROM SECTION 955.01(e) OF THE VILLAGE OF MANTUA CODIFIED ORDINANCES, CEMETERY CHARGES AND FEES, AND DECLARING AN EMERGENCY.**

**WHEREAS**, on or about October 1, 2012, the Village Administrator approved a resident digging a foundation at the Hillside Cemetery, and only charged the resident the actual cost to the Village of concrete used for said foundation; and

**WHEREAS**, such charge is inconsistent with the Village of Mantua Codified Ordinances section 955.01, relating to Cemetery Charges and Fees; and

**WHEREAS**, this Council deems it appropriate and necessary to retroactively approve this unique charge in order to avoid auditing irregularities.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** It is hereby found and determined that the charge of \$45.00 to Jeffrey Blunk for the cost of concrete relating to a foundation at the Mantua Hillside Cemetery sufficiently compensates the Village for its expenses relating to the same, and the charge is hereby ratified and approved.

**SECTION 2:** Permitting residents to perform work at the cemetery in return for reduced fees is inconsistent with the Village on Mantua Codified Ordinances and will not be authorized in the future.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Resolution is hereby declared an emergency measure, retroactive to October 1, 2012, in order to prevent irregularities for the 2011-2012 auditing period, and shall become immediately effective upon its proper passage by two thirds or more of the members elected to this Council.
