ORDINANCE 2013-78

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2013
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, the General Fund is in need of an increase in appropriations by \$25,000 in order to complete a transfer to the Sewer Operating Fund in the amount of \$20,000 and to increase appropriations in the Police Department by \$5,000 for telephone and motor vehicle expenses; and

WHEREAS, the Street Operations and Maintenance Fund is in need of an increase of unappropriated monies in the amount of \$10,000 in order to meet snow plow needs and other expenses; and

WHEREAS, the \$20,000 which is being transferred from the General Fund to the Sewer Operating Fund must be appropriated in order to haul sludge and make necessary repairs to the wastewater treatment plant.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustment to the 2013 Village Appropriations:

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, necessary to permit payment of the Village's expenses in a timely manner, to avoid permitting expenditures to exceed appropriations and to maintain correct accounting practices, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
