**RESOLUTION 2013-87**  
*(amended)*

**A RESOLUTION DESIGNATING THE MAYOR AS CONTACT PERSON FOR THE STATE DISASTER RELIEF PROGRAM AND AUTHORIZING THE MAYOR AND CLERK-TREASURER TO EXECUTE ALL NECESSARY INSTRUMENTS RELATED TO OBTAINING DISASTER RELIEF FUNDS, AND DECLARING AN EMERGENCY.**

**WHEREAS**, by passage of Ordinance 2013-67, this Council declared a State of Emergency as a result of the unprecedented rainfall of July 10, 2013; and

**WHEREAS**, in order to receive State Disaster Relief Funds the Village must designate a contact person and grant authority to submit required application materials and execute agreements; and

**WHEREAS**, this Council desires to designate the Mayor as contact person, and grant her authority, along with the Clerk-Treasurer, to execute necessary documents.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of all members elected thereto concurring, that:

**SECTION 1:** the Mayor is hereby designated as contact person for all matters relating to the application for funds from the State of Ohio Disaster Relief Program.

**SECTION 2:** The Mayor and the Clerk-Treasurer are hereby authorized to execute and submit all documents necessary to obtain State Disaster Relief funds.

**SECTION 3:** The Clerk-Treasurer is authorized to investigate and secure a temporary loan in order to enable her to certify the availability of funds for purposes of the grant application.

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning a relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance is hereby declared an emergency measure, in order to expedite the application for State Disaster Relief Funds, and to further ensure the health, safety and welfare of the inhabitants of the Village of Mantua, and shall become immediately effective upon passage by at least two-thirds of the members elected to the Mantua Village Council.
