Village of Mantua, Ohio ORDINANCE 2014-12

AN ORDINANCE ESTABLISHING PAY SCALES AND POSITIONS OF FULL AND PART TIME EMPLOYEES OF THE VILLAGE OF MANTUA, REPEALING PRIOR INCONSISTENT ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, the Mantua Village Service and Safety Committees have recommended to Council that employees within the Service Department and Police Department may be authorized for merit raises; and

WHEREAS, for convenience and efficiency, this Council wishes to enact a single item of legislation reflecting pay scales which will replace multiple existing wage and pay ordinances.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: Ordinance 2013-76 relating to pay rates for current employees is hereby repealed.

SECTION 2: Ordinance 2013-88 establishing pay scales and positions for Village employees is hereby repealed.

SECTION 3: The wage freeze enacted in 2007 remains lifted.

SECTION 4: Longevity pay remains frozen and employees currently receiving longevity pay will not receive additional longevity pay should their base hourly rate be raised.

SECTION 5: Merit raises from current rates within the ranges listed below may only be granted upon recommendation of the Department Head to the Mayor and the Mayor's written approval.

SECTION 6: Any raises outside of the ranges listed below must be approved by Council.

SECTION 7: Effective immediately, the following positions and compensation ranges of full and part time Village employees, where such positions and compensation are not provided for in separate legislation, are hereby established:

SECTION 8: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 9: This Ordinance is hereby declared an emergency measure in order to authorize merit raises for Police and Service Department employees beginning with the next pay period, and shall become effective immediately upon its passage by at least two-thirds of the members elected to the Mantua Village Council.
