A RESOLUTION AUTHORIZING A MEMORANDUM OF UNDERSTANDING WITH JAMES AND DEBORAH HAYLETT, AND DECLARING AN EMERGENCY.

WHEREAS, James and Deborah Haylett have executed a Memorandum of Understanding ("MOU"), attached hereto and incorporated herein by reference as "Exhibit A", expressing a commitment to execute an Easement in favor of the Village of Mantua relating to existing signage at the intersection of Canada Road and State Route 44; and

WHEREAS, in consideration of the commitment made by the Hayletts, this Council wishes to authorize the Mayor to execute the MOU, acknowledging the Hayletts' commitment and stating that this Council will bring Ordinance 2013-100 to the floor for a vote.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: This Council authorizes and directs the Mayor of the Village of Mantua to execute a Memorandum of Understanding with James and Deborah Haylett, in substantially the same form as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure, in order that the Memorandum of Understanding may be executed at the earliest possible time, and for that reason this Resolution shall take effect immediately upon proper passage by the Council.

EXHIBIT A

MEMORANDUM OF UNDERSTANDING BETWEEN JAMES E. HAYLETT, III AND DEBORAH HAYLETT AND THE VILLAGE OF MANTUA, OHIO

- WHEREAS, The Village of Mantua is the owner of an "orphan" parcel of land containing approximately 0.012 acres and located immediately northeast of the intersection of Canada Road and State Route 44 within the Village, and being part of Portage County Permanent Parcel No. 24-040-20-006-006 (the "Property") as described in "Exhibit One", attached hereto and incorporated herein by reference;
- WHEREAS, In conjunction with Ohio Department of Transportation (ODOT) project number 82913, the Village is authorized to transfer said Property to ODOT, which may, at the completion of the project, dispose of the Property if it is no longer needed for ODOT purposes;
- **WHEREAS**, The Village of Mantua has erected certain signage, partially upon this Property, for which it will require an easement if the Property is no longer under Village ownership and control;
- **WHEREAS**, James E. Haylett, III and Deborah Haylett ("the Hayletts") desire to obtain the Property from ODOT once it is no longer needed for project 82913;
- WHEREAS, in order to provide assurances that the Village of Mantua signage located on the Property will be permitted to remain and be maintained in its present location, the Hayletts wish to enter this Memorandum of Understanding, expressing their commitment to execution of an Easement in favor of the Village of Mantua relating to the continued maintenance of the signage once the Property is transferred to the Hayletts.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein and intending to be bound hereby, the parties hereto agree as follows:

- 1. By execution of this Memorandum of Understanding, the Hayletts do hereby agree to execute an Easement in favor of the Village of Mantua which will permit the continued placement and maintenance of existing Village of Mantua signage on permanent parcel numbers 24-040-20-00-006-006 and 24-041-40-00-015-000 at such time as the Property is transferred to the Hayletts.
- 2. Upon execution of this Memorandum of Understanding by the Hayletts, the Council of the Village of Mantua will proceed to consider and vote upon Ordinance 2013-100, authorizing the conveyance of the Property, to the Ohio Department of Transportation.
