

**Village of Mantua, Ohio  
Ordinance 2015-28**

**AN ORDINANCE FINDING THE BID OF KIMBLE RECYCLING AND DISPOSAL, FOR THE EXCLUSIVE PROVISION OF RESIDENTIAL CURBSIDE RECYCLING SERVICES WITHIN THE VILLAGE, TO BE THE LOWEST AND BEST BID SUBMITTED, AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACTUAL AGREEMENT WITH SAID BIDDER, AND DECLARING AN EMERGENCY.**

**WHEREAS**, pursuant to Ordinance 2015-23, the Village of Mantua has solicited bids for the provision of residential curbside recycling collection services; and

**WHEREAS**, the bids so received have been publicly opened on July 21<sup>st</sup>, 2015, at 6:30 p.m., pursuant to the public notices relating to the solicitation of such bids; and

**WHEREAS**, this Council has considered the bids submitted and has determined that Kimble Recycling and Disposal has tendered the lowest and best bid among those to respond to the request for bids.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** The bid of Kimble Recycling and Disposal for the exclusive provision of residential curbside recycling collection services within the Village of Mantua, pursuant to “Exhibit A”, attached hereto and incorporated herein by reference, is hereby determined to be the lowest and best bid submitted.

**SECTION 2.** The Mayor of the Village of Mantua is hereby authorized and directed to enter into a contractual agreement with the successful bidder named in Section 1, herein, for the exclusive provision of residential curbside recycling collection services within the Village of Mantua.

**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare of the Village of Mantua, in order to permit the execution of a contract for the provision of curbside recycling services at the earliest possible time so that such services may commence on September 1, 2015, wherefore, this Ordinance shall be in full force and effect immediately upon proper passage by this Council.
