ORDINANCE 2017-14

AN ORDINANCE MODIFYING THE SWIMMING POOL SEWER CHARGE REDUCTION QUESTIONNAIRE AND AGREEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Administrator has requested that the sewer charge reduction related to the filling of swimming pools be changed from a separate billing of the water consumed to a reduction of the sewer charges on the customer's billing statement; and

WHEREAS, the Swimming Pool Sewer Charge Reduction Questionnaire and Agreement established with the passage of Ordinance 2014-53 must be modified to address this recommendation.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: "Exhibit B" of Ordinance 2014-53 is hereby repealed.

SECTION 2: The Village of Mantua Swimming Pool Sewer Charge Reduction Questionnaire and Agreement is hereby adopted as set forth in "Exhibit A", attached hereto and incorporated herein by reference.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared an emergency measure, in order to authorize an updated pool credit form for the current season, and shall become immediately effective upon passage by at least two-thirds of the members elected to the Mantua Village Council.

**VILLAGE OF MANTUA SWIMMING POOL SEWER CHARGE REDUCTION
QUESTIONNAIRE AND AGREEMENT**

THIS AGREEMENT IS TO DETERMINE THE AMOUNT TO BE DEDUCTED FROM THE CUSTOMER'S SEWER BILL FOR SWIMMING POOL WATER THAT WILL NOT ENTER INTO THE VILLAGE OF MANTUA'S SANITARY SEWER SYSTEM. This will be a once a year reduction in sewerage charge permitted under Codified Ordinances section 941.14(1)(2) and can be taken between May 1st and July 31st only.

Forms must be filled out annually.

THIS FORM IS TO BE COMPLETED PRIOR TO FILLING YOUR POOL IN ORDER TO RECEIVE A POOL CREDIT. YOU MUST MAKE AN APPOINTMENT TO HAVE SERVICE DEPT PERSONNEL COME OUT TO TAKE THE BEGINNING AND ENDING READING OF YOUR METER AND YOU WILL HAVE 3 DAYS TO FILL YOUR POOL.

Your account balance must be paid in full (not on a payment plan) to be approved for a pool fill up credit. The credit will be based on the lesser of the calculated volume of water used or the meter reading. You will receive a sewer credit on your next bill, which must be paid in full by the due date in order to receive the credit. Late payments will result in the credit being revoked.

I hereby request that a sewer charge reduction be given on this pool filling for the above amount of water.

I hereby certify that this water will not enter into the sanitary sewer system and only into the storm sewer after being de-chlorinated.
