RESOLUTION 2018-20

A RESOLUTION SUBMITTING TO THE ELECTORS OF THE VILLAGE OF MANTUA THE QUESTION OF RENEWAL OF THE 3.85 MILL TAX LEVY FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING AND REPAIR OF STREETS, ROADS AND BRIDGES WITHIN THE VILLAGE, PURSUANT TO OHIO REVISED CODE SECTIONS 5705.19(G) AND 5705.191.

WHEREAS, on March 20, 2018, this Council adopted Resolution No. 2018-17 pursuant to Section 5705.03 of the Ohio Revised Code, declaring it necessary to renew the current five year, 3.85 mill road levy, originally approved by the electors of the Village of Mantua on November 4, 2014, for the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the Village which will expire at the end of 2018, and requesting the Portage County Auditor to certify the total current tax valuation of the Village and the dollar amount of revenue which would be generated by the renewal of said levy; and

WHEREAS, on March 22, 2018, the Portage County Auditor certified that the total current tax valuation of the Village is \$19,856,150.00, and that the estimated property tax revenue that would be produced by the renewal of the 3.85 mill levy would be \$76,352.00, assuming that the total current tax valuation of the Village remains the same during the life of the levy.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mantua, State of Ohio, a majority or more of the members elected thereto concurring, that:

SECTION 1. This Council finds, determines and declares that the amount of taxes that may be raised by the Village of Mantua within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of this Village, and that it is necessary to renew an existing property tax outside of the ten-mill limitation, for the general construction, reconstruction, resurfacing, and repair of streets, roads and bridges in the Village pursuant to Ohio Revised Code section 5705.19(G).

SECTION 2. Such Renewal Levy shall be for five (5) years and at a rate not to exceed 3.85 mills annually for each One Dollar (\$1.00) of tax valuation or \$0.385 for each One Hundred Dollars (\$100.00) of tax valuation and to be levied on the real property tax duplicate for the whole of the Village of Mantua, Ohio, in excess of the rate authorized by statute.

SECTION 3. The question of the renewal of the 3.85 mill levy shall be submitted to the electors of the Village of Mantua, Portage County, Ohio, for their approval or rejection, at the General Election to be held on the 6th day of November, 2018 at the regular place of voting in this Village as established by the Board of Elections of Portage County, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law.

SECTION 4. If approved by a majority of electors voting thereon, such renewal tax levy shall be placed upon the tax list and duplicate beginning with the year 2019, the proceeds of which levy first would be due and collected and made available to the Village in calendar year 2020.

SECTION 5. The Clerk-Treasurer of the Village of Mantua is hereby authorized and directed to give or cause to be given notice of that election as provided by law.

SECTION 6. The Clerk-Treasurer is hereby authorized and directed to certify a copy of this Resolution, together with Resolution No. 2018-17, adopted March 20, 2018, and the related Certificate of the Portage County Auditor, to the Portage County Board of Elections before the close of business on August 8, 2018.

SECTION 7. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of the State of Ohio.

SECTION 8. This Resolution shall be in full force and effect after proper passage by the Mantua Village Council at the earliest period allowed by law.
