ORDINANCE 2018-43

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2018
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, the Probate Court has approved a \$4,000 annual contribution from the Delia Thompson Trust towards the purchase of a new truck for the service department; and

WHEREAS, funds must be appropriated in the Capital Projects Fund 4905 in order to contribute to the purchase of the new truck for the service department; and

WHEREAS, funds must be appropriated in Water Capital Improvement Fund 5761 and the Sewer Capital Improvement 5762 in order to pay for new dehumidifiers at the water plant and replacement of the VFD's (Variable Frequency Drives) in the wastewater plant.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustments to the 2018 Village Appropriations:

SECTION 3. This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
