**ORDINANCE 2019-04**

**AN ORDINANCE RELATING TO RATIFICATION OF THE SOLID WASTE  
MANAGEMENT PLAN FOR THE PORTAGE COUNTY SOLID WASTE  
MANAGEMENT DISTRICT.**

**WHEREAS**, the Village of Mantua (Village) is located within the jurisdiction of the Portage County Solid Waste Management District (District); and

**WHEREAS**, the District Policy Committee has prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53 3734.54 and 3734.55; and

**WHEREAS**, the District has provided a copy of the Draft Final Solid Waste Management Plan for ratification to each of the legislative authorities of the District; and

**WHEREAS**, the legislative authority of the Village of Mantua must decide whether it approves of said Solid Waste Management Plan within ninety days of receipt of the Draft Final Plan; and

**WHEREAS**, the Service Committee has recommended disapproving the Plan.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Mantua, a majority or more of the members elected thereto concurring, that:

**SECTION 1:** The legislative authority of the Village of Mantua hereby  
approves/does not approve  
the Portage County Solid Waste Management Plan.

**SECTION 2:** The Clerk-Treasurer is hereby directed to send the District a copy of this Ordinance to the attention of William G. Steiner, II, Director, Portage County Solid Waste Management District, 3588 Mogadore Road, Kent, Ohio 44240.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance shall be in full force and effect after its passage by at least a majority of the members elected to the Mantua Village Council, at the earliest period allowed by law.
