**ORDINANCE 2021-07**  
**(amended)**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2021  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, any monies remaining in the water and sewer funds as well as their respective capital funds must be appropriated in order to pay final bills and payroll costs and turn the remaining funds over to the county pursuant to the Water and Sewer Utility Transfer Agreement; and

**WHEREAS**, the deadline for spending Local Coronavirus Relief Funds has been extended through December 31, 2021; therefore, remaining funds encumbered to pay payroll costs for Safety personnel but unspent in 2020 must be appropriated in order to be used to pay Safety personnel in 2021; and

**WHEREAS**, Cemetery Operating appropriations must be increased in order to reissue a purchase order securing donations for design of a monument for Jane Gonczy and Ruth Aldrich.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2021 Village Appropriations:

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
