**RESOLUTION 2021-59**

**A RESOLUTION AMENDING RESOLUTION 2021-53, WHICH AUTHORIZES THE INTERNET AUCTION OF THE VILLAGE-OWNED 2001 STERLING L75 TRUCK WITH SALT SPREADER, AND DECLARING AN EMERGENCY.**

**WHEREAS**, on October 19, 2021, this Council approved Resolution 2021-53, titled as follows:

A RESOLUTION DECLARING THE 2001 STERLING L75 TRUCK WITH SALT SPREADER NOT NEEDED FOR MUNICIPAL PURPOSES, AUTHORIZING THE VILLAGE ADMINISTRATOR TO DISPOSE OF THIS EQUIPMENT BY INTERNET AUCTION, AND DECLARING AN EMERGENCY.

and

**WHEREAS**, the Village Administrator advises that the snow plow attachment which is an essential component of the identified vehicle, and cannot be used with any other village vehicles, was inadvertently omitted from that legislation; and

**WHEREAS**, the Service Committee has recommended that Resolution 2021-53 be amended so that it includes all equipment associated with the vehicle to be auctioned.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** The title of Resolution 2021-53 is hereby amended to read as follows:

A RESOLUTION DECLARING THE 2001 STERLING L75 TRUCK WITH SALT SPREADER AND SNOW PLOW ATTACHMENT NOT NEEDED FOR MUNICIPAL PURPOSES, AUTHORIZING THE VILLAGE ADMINISTRATOR TO DISPOSE OF THIS EQUIPMENT BY INTERNET AUCTION, AND DECLARING AN EMERGENCY.

**SECTION 2.** Existing Sections 1 and 2 of Resolution 2021-53, approved by this Council on October 19, 2021, are hereby repealed.

**SECTION 3.** Resolution 2021-53 shall be amended by enacting Sections 1 and 2 thereof to read as follows:

**SECTION 1.** It is hereby determined that the 2001 Sterling L75 Truck, VIN# 2FZAATBS51AB51705, with salt spreader and snow plow attachment is obsolete and no longer fit for public use by the Village of Mantua.

**SECTION 2.** This Council hereby authorizes the Village Administrator or her designee to initiate an internet auction at [Govdeals.com](http://Govdeals.com), seeking bids for the 2001 Sterling L75 Truck, VIN# 2FZAATBS51AB51705, with salt spreader and snow plow attachment owned by the Village. Said auction shall have a duration of fourteen days and shall have a starting price of One Thousand Dollars (\$1,000.00).

**SECTION 4.** All other provisions of Resolution 2021-53, approved by this Council on October 19, 2021, shall remain in full force and effect.

**SECTION 5.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 6.** This Resolution is hereby declared to be an emergency measure, necessary to permit the disposition of obsolete equipment at the earliest possible time, and for that reason shall take effect immediately upon proper passage by Council.
